Over the past few months, the CARICOM Secretariat's Office of Trade Negotiations (OTN) has engaged in discussions with various private sector groups across CARICOM on the "Future Direction of CARICOM's External Trade Policy and Strategy". This has been done in response to a mandate issued by the 41st Meeting of the Council for Trade and Economic Development (COTED), that the region must embark on processes that will consolidate and update existing trade agreements and prioritize negotiations with countries in Central and South America.
